Terms & Conditions

MOTORCYCLE DAMAGE DEPOSIT

JH600 Motorcycle: 1000USD/motorcycle if you join our tours, 2000USD/motorcycle if you rent the motorcycle on Self Guided Tours.

JH250 CC Motorcycle: 500USD/motorcycle if you join our tours, 1000USD/motorcycle if you rent the motorcycle on Self Guided Tours.

Damage Deposit needs to be paid at the same time with the final balance.

DEFAULT OR DAMAGE

During the hire period Ride China is not obliged to replace a damaged motorcycle, but will do our best to get you back on the road as soon as possible. Where a bike is damaged, due to the participant dropping the bike or crashing (irrespective of fault), all repairs and replacement of parts that are damaged are at the cost of the hirer. We will not charge you for minor scuffs and scrapes or wear and tear that are as a result of general acceptable usage. We will refund the damage deposit if the motorcycle is not damaged.

CANCELLATION TERMS If it becomes necessary for you to cancel your trip, the following fees will apply, computed as of the date of receipt of written cancellation notice, which can be sent by email, fax.

45 + days - 10% of tour cost	45 + days - 5% of tour cost
30-44 days - 20% of tour cost	30-44 days - 10% of tour cost
15-29 days - 50% of tour cost	15-29 days - 25% of tour cost
8-14 days - 75% of tour cost	8-14 days - 35% of tour cost
0-7 days - No refund	0-7 days - 50% of tour cost

International airline ticket refunds are the responsibility of the tour participant, so please ensure purchase of adequate tour cancellation insurance at the time of tour balance invoice payments and air ticket purchases!

Limited Liability

Ride China is not liable for any bodily injury or property damage as a result of (but not limited to): physical exertion for which a guest is not prepared; forces of nature; travel by motorcycle, or other form of active or adventure travel; consumption of alcoholic beverages; civil unrest; terrorism; breakdown of equipment; high altitude; lack of or limited access to medical attention in remote locations; the adequacy of medical attention once provided, speeding, parking tickets, or road tolls, or any other circumstances beyond its control. Nor shall Ride China be responsible or liable for delay, loss, damage or injury to person or property and illness incurred during their stay in connection with or relating to the supply or omission of air, sea, land transportation services, or of accommodation, meals, facilities, entertainment or other services provided by Ride China. Ride China reserves the right to make route and hotel modifications as necessary to improve the trip quality or to accommodate the comfort and well-being of guests. Guests grant Ride China express permission to take photographs or make film records of its trips for promotional and commercial use, as well as approve such use by third parties with whom Ride China may engage in joint marketing, without financial remuneration.

Insurance

All rentals and tours include third party motorcycle insurance covering the third party's damage on a limited fund of 300USD. Due to the law and the nature of our trips in China and the remoteness of our destinations, insurance is highly recommended. While Ride China will attempt to secure the hospitals' services in case of an emergency, we cannot guarantee the same standard you have at home, and assume no liability regarding provision of medical care. We strongly urge each tour member to purchase travel insurance that covers a range of adventure activities such as motorcycling and to cover themselves for trip cancellation and medical evacuation. I understand and agree to all the conditions as stated in the above paragraphs.
